Mr. Rumbough presented to the Council a Planning Department recommendation for draining a section off Terry Circle in Glendale Acres, Section I. A motion was made by Councilman Rhodes, seconded by Councilman Plummer to approve, subject to City Engineer and Public Works Commission approval, and was approved unanimously.

Mr. Rumbough presented for final approval a plat of Edenroc Subdivision east of Cumberland Heights off Bragg Boulevard to the Council. The motion was unanimously carried, subject to approval by the City Engineer and Public Works Commission, upon a motion made by Councilman Plummer, seconded by Councilman Maness.

Regarding the above subdivision; Mr. Ray, City Manager, presented a request from Mr. Henry Andersontto permit the developers of Edenroc subdivision to contract privately for the street paving with the city participating to its usual extent in the cost of such paving. A motion was made by Councilman Plummer, seconded by Councilman Rhodes that the above be permitted under supervision of the City Engineering Department, was unanimously approved.

Mr. Rumbough, City Planner, requested a discussion of water and sanitary sewer extension into College Lakes Subdivision off Raleigh Road, which is outside the city limits, for the clarification of the City Planning Board.

Mr. Muench, Public Works Commission administrator, stated developers, acting in good faith, had done all that they thought they were required to do and that any further delay (in the extension of water & sewer utilities) to Section III would be an injustice. He further stated that developers were willing to invest approximately \$100,000.00 to install water and sanitary sewer utilities into Section III of College Lakes which would serve 140 lots. He stated in his opinion that Public Works Commission should proceed with the installation of water and sanitary sewer utilities as discussed with them in past.

Following a discussion of the matter, Councilman Rose moved that the Council approve the extension of water and sanitary sewer utilities into Section III of College Lakes subdivision provided the plat discrepancies could be worked out by the Planning Board and the developers. The motion was seconded by Councilman Plummer and unanimously approved.

Mr. W. H. Burgett, requested a privilege license to conduct radio and TV repair work at his home, 312 Barret Street. A motion made by Councilman Rose, seconded by Councilman Maness, was unanimously approved.

Mr. Ray read a letter from Mr. vonRosenberg, Chairman of Advisory Commission on proposed purchase of Person property. The letter stated that the Committee would meet on Wednesday, necessary of the Council since prior approval to purchase land had been given subject to a favorable report by the Committee.

A Council meeting to discuss the preliminary budget for 1961-62 was set for 7:30 P.M., Thursday, June 15, 1961. This was later changed to 3:00 P.M. same date.

Upon a motion by Councilman Plummer, seconded by Councilman Rhodes and unanimously approved, the Council rejected an offer from Mr. M. G. Vann for sale of a lot on Winslow and Bass Streets to the city for a public parking lot site. The report from Committee indicated that revenue from this lot would not justify purchase of lot at price offered.

Mr. Ray read a notice from the Institute of Government, University of North Carolina, Chapel Hill, of a school for Mayors and Councilmen to be held from June 25th to 27th. A motion made by Councilman Plummer, and seconded by Councilman Rose to waive Council meeting of June 26th and authorize Mayor and members of Council to attend this meeting was unanimously approved.

A motion by Councilman Plummer that a street paving petition for Commerce Street be advertised and a public hearing set for July 10th was seconded by Councilman Maness and unanimously approved.

Mr. Ray requested permission of the Council to attend a meeting of the Board of Directors, International City Managers' Association, in Washington, D. C. on Saturday and Sunday, by Councilman Maness.

City Attorney, J. O. Tally, Jr., requested that the Council approve the title of the new City Code as follows: "The Code of the City of Fayetteville, N. C." Upon a motion made by Councilman Plummer, seconded by Councilman Rose, the above title was unanimously approved.

Attorney Tally presented for approval an agreement for an approach road right-of-way to Carver's Creek Park area between city and Norfolk-Southern Railroad. A motion made by Counciltract was seconded by Councilman Rose, was unanimously approved.

Councilman Rhodes inquired of Attorney Tally if time permitted the introduction at the current session of the state legislature, a bill giving citizens of city authorization to vote on now, and that a better course would be to develop plans well in advance and introduce bill early in next session of general assembly.

There being no further business and upon motion by Councilman Plummer, seconded by Councilman Rhodes, the meeting was adjourned at 9:45 P. M.

A special meeting of the City Council was held in the Executive Chamber at 3:00 P. M., Tuesday, June 15, 1961 to discuss the Preliminary Budget for the fiscal year 1961-62.

Mayor Butler read a letter of appreciation and an offer of assistance from Mr. V. C. Mason, District Principal of District Five Schools-Cumberland County regarding the proposed park and recreation center in Massey Hill.

Mr. Ray, City Manager, read a letter from Mr. vonRosenberg, Chairman of Parks and Recreation Advisory Commission pertaining to the purchase of the Ila C. Persons tract of land. The Commission recommended the purchase of the tract at a price of \$35,000.00 subject to a survey by the Engineering Department and a title check by the City Attorney.

Mr. Ray presented to the Council the Preliminary Budget for 1961-62. This was reviewed and discussed in general.

Relative to the 1961-62 Budget request from City Recorder's Court; Mr. Ray read a letter from City Recorder's Court Judge Derb S. Carter on activities and operation of the court for the past year.

Councilman Rose informed the Council that he attended a luncheon meeting at which our status as a depressed area was discussed. He further reported that a committee of civic leaders was being organized to study our problem and that a suggestion was made at the meeting that the City Council be represented on the committee. After a brieff discussion, Councilman Plummer made a motion that Councilman Rose be appointed as a member to serve on the committee representing the City Council. The motion was seconded by Councilman Maness and unanimously approved.

Tuesday, June 20th at 3:00 P. M. was set as the date for further discussion by Council of the 1961-62 budget.

There being no further business, the meeting was adjourned at 5:30 P. M. upon motion by Councilman Plummer, seconded by Councilman Rhodes.
