stated that he had also been contacted by telephone by Mr. L. A. Faucette, 2710 Pecan Drive who stated that he and a Mrs. Miller and several others who were unable to attend the meeting, were also opposed to the rezoning. A further poll of the audience by Mayor Butler revealed no persons present in favor of the rezoning.

Planning Director Rumbough stated that it was Planning Board's recommendation that the petition be denied.

Councilman Plummer than moved that the request be denied. Motion was seconded by Councilman Rhodes and unanimously carried.

A public hearing having been advertised, as required and there being no opposition present and on motion by Councilman Rose, seconded by Councilman Maness, the Council voted to amend the City's Zoning Ordinance as follows:

> Rezone from R-5 Residential District to M-2 Industrial District an area on Robeson Street and Weiss Avenue described as follows:

BECINKING at a point in the center line of Hobeson Street approximately 100 feet northward from its intersection with the northern end of Weiss Ave. said point being a corner in the zoning boundary between the R-5 Residential District and M-2 Industrial District; and running thence with said boundary line in a southeasterly direction approximately 250 feet to a corner in said boundary line; and running thence with said boundary line in a southerly direction approximately 350 feet to the center of Blounts Creek; and running thence with the center of Blounts Creek in a southwestwardly direction approximately 1100 feet to the beginning.

Mr. Sneed H igh again presented a proposed amendment to the city's Taxicab Ordinance as relates to the transfer and assignment of Taxicab Certificates.

Mr. High spoke at length regarding the proposed amendment.

There was then considerable discussion by the Council of the city's method of issuance of certificates under it's present ordinance as weighed against the proposed amendment.

# AN ORDINANCE UPON DANCE HALLS and PUBLIC CONDUCT THEREAT and ELSEWHERE

No person shall yell, shout, hoot, whistle, sing or make any kind of unnecessary noise upon any public street or at or in or near any dance hall or other place of public meeting or assembly or entertainment or at any place in the City, at any time, so as to annoy or disturb the quiet, comfort or repose of persons in any office, dwelling, hotel or other residence, or of any persons in the vicinity.

No person in the City shall disturb, tend to disturb, or aid in disturbing the peace of others by violent, tumultuous, offensive or obstreperous conduct, and no person shall knowingly permit such conduct upon any premises owned or possessed or rented by him or under his control.

No public dance within the City to which persons are admitted by the payment of money rather than upon invitation without payment of money shall be conducted and continued upon any night beyond the hour of 12:00.
