Councilman Plummer moved that an architect be hired to plan and design Fire Station #5 to be constructed on the lot situated on Owen Drive deeded to the city by Mr. Sandrock. Motion was seconded by Councilman Rhodes and carried.

There being no further business before the Council and upon motion by Councilman Plummer, the meeting was adjourned at 5:00 P. M.
